**BENEDICT M. ASHLEY, O.P.**, is Professor Emeritus of Aquinas Institute of Theology, St. Louis. He is a member of the American Catholic Philosophical Association, the Catholic Theological Society, and the American Maritain Association, and has published *Theologies of the Body: Humanist and Christian* (1985), *Spiritual Direction in the Dominican Tradition* (1995), *Justice in the Church: Gender and Participation* (in press), and with Kevin O'Rourke, *Ethics of Health Care* (2nd ed., 1994), and *Health Care Ethics: A Theological Approach* (4th ed., in press).

**DON T. ASSELIN**, an Associate Professor of Philosophy at Hillsdale College in Michigan, has written several reviews and scholarly articles on Maritain. He is the author of the book *Human Nature and Eudaimonia in Aristotle*. He also has published in the areas of ethics, medical ethics and the philosophy of religion.

**MICHAEL BAUR**, Assistant Professor in the School of Philosophy at The Catholic University of America, received his Ph.D. from the University of Toronto. He is currently pursuing legal studies at Harvard Law School and is working on a translation of J.G. Fichte's *Foundations of Natural Right* for Cambridge University Press.

**DAVID B. BURRELL, C.S.C.**, is currently Theodore Hesburgh Professor in Philosophy and Theology at the University of Notre Dame, and has been working since 1982 in comparative issues in philosophical theology in Judaism, Christianity, and Islam, as evidenced in *Knowing the Unknowable God: Ibn-Sina, Maimonides, Aquinas* (Notre Dame, 1986) and *Freedom and Creation in Three Traditions* (Notre Dame, 1993).

**ROMAN T. CIAPALO** is Associate Professor of Philosophy at Loras College, Dubuque, Iowa, and Director of the Loras College "Classical Philosophy Lecture Series," which he established in the Spring of 1990. He received his Ph.D. in philosophy from Loyola University of Chicago. He has lectured nationally and

internationally in New Delhi, Bratislava, and Ukraine. He has been the recipient (1991) of a Fulbright-Hays Summer Seminar Grant and in 1993-94 was a Fulbright Lecturer in Ukraine. He has published articles on Neoplatonism and is currently working on a translation into English of the collected works of the 18th century Ukrainian philosopher, Hryhorij Skovoroda.

**JOHN DEELY** is Professor of Philosophy at Loras College, Dubuque, Iowa. He has been a Fulbright Scholar to Brazil and, most recently, Mexico. He is one of the leading authorities in the field of semiotics, and has published numerous articles and books, among them *The Human Use Of Signs or Elements of Anthroposemiosis* and *New Beginnings: Early Modern Philosophy and Postmodern Thought*. In addition, he has published (The University of California Press) the critical bilingual edition of *Tractatus de Signis: The Semiotic of John Poinset*.

**JUDE P. DOUGHERTY** is Dean of the School of Philosophy of The Catholic University of America and editor of *The Review of Metaphysics*. He has written extensively on social and political topics and regularly lectures on issues confronting the philosophy of law and the philosophy of religion.

**CURTIS L. HANCOCK** is Professor of Philosophy at Rockhurst College, Kansas City, Missouri. He is co-author of *How Should I Live?*, a book on ethics, and co-editor of *Freedom Virtue, and the Common Good*, a book on political philosophy also produced by the American Maritain Association. He is currently the vice president of that association and is associate editor of *Contemporary Philosophy*. He has published articles on Plotinus and Maritain and on topics pertaining to political philosophy and ethics.

**THOMAS HIBBS** is Associate Professor of Philosophy at Boston College. He earned his B.A. at the University of Dallas in 1982, and a year later was awarded the M.A. He received his Ph.D. from Notre Dame in 1987. He is the author of a book forthcoming from the University of Notre Dame Press: *Dialectic and Narrative in Aquinas: An Interpretation of the Summa Contra Gentiles*.

**GREGORY J. KERR**, is an Assistant Professor of Philosophy at Allentown College of St. Francis de Sales in Center Valley, Pennsylvania. He is editor of *The Maritain Notebook*, the newsletter of the American Maritain Association and has written chronicles of past meetings of the AMA for both *Notes et Documents* and *Vera Lex*.

**JOHN F. X. KNASAS** is Professor of Philosophy in the Center for Thomistic Studies at the University of St. Thomas, Houston. He is the author of *The Preface to Thomistic Metaphysics: A Contribution of the Neo-Thomist Debate on the Start of*

*Metaphysics* and of many articles on Thomistic metaphysical concerns that appear in *The Thomist*, *The Modern Schoolman*, *The American Philosophical Quarterly*, *Divus Thomas*, *Doctor Communis* and *Angelicum*. He is the editor of *Jacques Maritain: The Man and His Metaphysics* and more recently *Thomistic Papers VI* which contains assessments of Gerald McCool's *From Unity to Pluralism: The Internal Evolution of Thomism*.

**JOSEPH W. KOTERSKI, S.J.**, (Ph.D., St. Louis University, 1982) teaches in the department of philosophy at Fordham University and is the Editor-in-Chief of *The International Philosophical Quarterly*. His research interests include medieval philosophy and the relation of religion to culture.

**JAMES MARSH** is Professor of Philosophy at Fordham University, teaches and writes in the areas of 19th century Continental Philosophy, phenomenology, hermeneutics, critical theory, and Lonergan, and has published over fifty articles and four books, the last one being *Critique, Action, and Liberation*.

**MATTHEW S. PUGH** holds a B.A. in philosophy from Florida State University, an M.A. in history from Ohio State University, and a Ph.D. in philosophy from Fordham University. He is currently Assistant Professor of Philosophy at the University of St. Thomas, in Houston, Texas, and a member of its Center for Thomistic Studies. Dr. Pugh's interests lie in the area of Thomist metaphysics and epistemology, particularly as interpreted by Jacques Maritain. Ongoing research projects include examining the relationship between the philosophies of Bergson and Maritain on the intuition of being, and problems in the epistemology of the basic judgement of existence.

**GREGORY M. REICHBERG** has taught at the Catholic University of America, and at Fordham University, where he is presently Associate Professor of Philosophy. After predoctoral studies in France at the Université de Toulouse and the Centre Indépendent de Recherche Philosophique, he received his Ph.D. in philosophy from Emory University in 1990. He has published articles on the ethics of knowing, philosophical issues in theology, and the philosophy of science.

**ROBERT ROYAL** is the Vice President for Research and Olin Fellow in Religion and Society at the Ethics and Public Policy Center (Washington, D.C.). He is author of *1492 and All That: Political Manipulations of History* and co-editor with George Weigel of *Building the Free Society: Democracy, Capitalism and Catholic Social Teaching*, and with Virgil Nemoianu of *Play, Literature and Religion: Essays in Cultural Intertextuality*.

**JAMES V. SCHALL, S.J.**, is a Professor in the Department of Government at Georgetown University. He has taught in the Gregorian University in Rome and at the University of San Francisco. He has written sixteen books, among which are *Another Sort of Learning*; *Unexpected Meditations Late in the XXth Century*; *Reason, Revolution and the Foundations of Political Philosophy*; and *Redeeming the Time*.

**ROSALIND SMITH EDMAN** is an Assistant Professor of Theology at Allentown College of St. Francis de Sales, Center Valley, PA. She presently teaches a Values Seminar focusing on contemporary woman in the context of Christian Humanism. Professional memberships include the American Maritain Association, College Theology Society, and the Catholic Theological Society of America.

**BRENDAN SWEETMAN** is Assistant Professor of Philosophy at Rockhurst College, Kansas City, Missouri. He is a native of Ireland and was educated at University College, Dublin, and at the University of Southern California, in Los Angeles, where he obtained his Ph.D. He is co-editor of an anthology in the philosophy of religion, *Contemporary Perspectives on Religious Epistemology* (Oxford University Press, 1992). He has published and presented several papers on the philosophy of Gabriel Marcel, and on recent Continental Philosophy. He is a member of the Executive Committee of the Gabriel Marcel Society.

**JOSEPH M. DE TORRE, M.A., Ph.D.** (Angelicum) holds the SEASFI Professorial Chair of Social and Political Philosophy at the Manila based Center for Research and Communication, where he has been teaching since 1970. He has published more than twenty books and many articles. He is a member of the Fellowship of Catholic Scholars, the American Catholic Philosophical Association, the American Maritain Association, the Society of Catholic Social Scientists, and the Royal Institute of Philosophy.

**MEROLD WESTPHAL** is Professor of Philosophy at Fordham University. In addition to two books on Hegel, he is the author of *Kierkegaard's Critique of Reason and Society*; *God, Guilt, and Death: An Existential Phenomenology of Religion*, and *Suspicion and Faith: The Religious Uses of Modern Atheism*.

**ROBERT E. WOOD** is Professor of Philosophy at the University of Dallas. He is a past (1995) president of the American Catholic Philosophical Association and editor of *American Catholic Philosophical Quarterly*. He has written *Martin Buber's Ontology*; *A Path into Metaphysics: Phenomenological, Hermeneutical and Dialogical Studies*, and is currently completing a work on *Approaches to Aesthetics*.
